

Model Release

The purpose of this model release is to explicitly state the purposes for which the images covered by this release may be used, by both the photographer and the model. Any use not explicitly stated in this document is prohibited and will require an additional release signed by both parties. The photographer named below will retain the document original. The model may request a copy of said document. Any changes should be clearly marked and initialed by both parties on all copies of the release.

As model, in consideration of my engagement as a model on the date specified, I hereby grant to the photographer the irrevocable rights to the images of me for the following purposes:

- The images may be used for the self-promotion of the photographer, in either print or electronic form.
- The images may be used for any other lawful personal use or professional use.
- Model will not sell or otherwise transfer publication rights to any of the photos without Photographer's prior consent.
- Model hereby releases and agrees to hold harmless Photographer and those acting under his permission, from any liability by virtue of blurring, distortion, alteration, optical illusion, or use in composite form whether intentional or otherwise, that may occur or be produced in the taking of the pictures, or in any processing tending toward the completion of the finished product, unless it can be clearly shown that the foregoing was maliciously caused, and produced, and published solely for the purpose of subjecting Model to conspicuous ridicule, scandal, reproach, scorn, and indignity.

As photographer, who holds the copyright on the images, I hereby grant irrevocable, non-exclusive rights to the model for use of the images in the following ways:

- The images may be used for the self-promotion of the model, in either print or electronic form, by both the model and his/her agents and assignees, as long as each image is accompanied by a photo credit or copyright notice naming the photographer.
- The images may be used in exhibitions and contests, providing each image is accompanied by a photo credit or copyright notice naming the photographer.
- The images may be used for any other lawful personal or non-commercial professional use.
- The images will not be altered, modified or manipulated whether digitally or physically.
- The photographer, his heirs, legal representatives and those acting with the photographer's permission agree/s not to use or allow the images of the model in whole or in part to be used to sell or promote sex, or to be used in conjunction with pornography, drugs, violence, or illegal/illicit activities.
- The photographer is responsible for the incurring costs of the shoot.
- Permission to PRINT said images are hereby granted at locations that require copyright release.

As model, I certify that I am of full legal age and have the right to contract in my own name without breach of any prior agreement or applicable law, including, but not limited to, prior agreements with modeling and talent agencies. I further certify that I have read this release and agreement prior to its execution and that I am fully familiar with, understand, and am in agreement with its contents. Finally, I certify that the photo-session was conducted in a professional manner and all poses, positions and situations enacted in the photos covered in this release were entered into without force, coercion, or threat whatsoever, and were posed freely by Model with Model's full consent. Model further agrees to hold blameless and free of all accusation of such force or coercion by Photographer, his legal representatives, assigns, and those acting under his permission.

Both Model and Photographer affirms to have read the foregoing prior to its execution and agree to the contents thereof. **It is recommended that the model consult an attorney to review this model release before signing.**

Model's Compensation:

- Copy of agreed number of images on CD or digitally delivered and a copy of this release.
- The images may be used for the self-promotion of the model, in either print or electronic form, by both the model and his/her agents and assignees, as long as each image is accompanied by a photo credit or copyright notice naming the photographer.
- The images may be used in exhibitions and contests, providing each image is accompanied by a photo credit or copyright notice naming the photographer.
- The images may be used for any other lawful personal or non-commercial professional use.
- Permission to PRINT said images are hereby granted at locations that require copyright release
